



## **Notice of Availability of Draft Supplemental EA/EIR for American River Watershed Common Features, Water Resources Development Act of 2016, American River Contract 1 (Project)**

**Project Location:** The Project is located in the City of Sacramento, California along the left bank (when facing downstream) of the American River from Glenn Hall Park and extending past the H Street Bridge.

**Project Description:** The U.S. Army Corps of Engineers (USACE), Central Valley Flood Protection Board (CVFPB), and Sacramento Area Flood Control Agency (SAFCA) propose to construct an approximately 5,500-foot-long bank stabilization project. Most of the levee improvements included in the project were analyzed in the American River Watershed Common Features General Reevaluation Report (ARCF GRR) Environmental Impact Statement/Environmental Impact Report (EIS/EIR). This Supplemental Environmental Assessment/EIR (EA/EIR) addresses project modifications and refinements since publication of the ARCF GRR EIS/EIR.

Following the requirements of the California Environmental Quality Act (CEQA), a Supplemental EA/EIR has been prepared for this project. The results of the Draft Supplemental EA/EIR indicate that most of the potential adverse effects that could result from implementation of the proposed alternative would either be short term or would be avoided or reduced to less than significant by using best management practices. However, analysis indicates potential short term significant and unavoidable effects on visual resources, vegetation and wildlife, recreation, and traffic and circulation.

The Draft Supplemental EA/EIR also provides the opportunity for public and agency involvement and comment. During the 45-day public review period, a virtual public meeting will be held to discuss the proposed project and accept public questions and comments. The public meeting will be held on June 15, 2020 at 4:00 P.M. 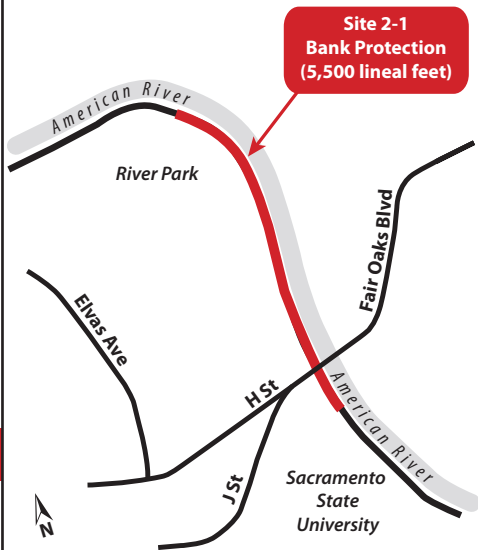
