As a transgender woman and community organizer I wrote a resolution and organized a coalition of local partners to make Sacramento a sanctuary city for transgender individuals and gender affirming healthcare. I've also worked during devastating storm events to help our unhoused neighbors survive torrential rain, high winds, and falling trees - providing food, tarps, and hand warmers to the most desperate people at the most desperate time. From my advocacy, I have come to understand that marginalized communities are often hit first and worst by climate disaster. Thus to protect marginalized communities, as a trustee I plan to continue ARFCD's goals to mitigate climate disaster through routine levee maintenance and to build resilient communities along the American River through education and open space access.
